1. **Discussion and action on moving forward with a feasibility study on wind power generation for municipal buildings**


President Walker, Sue Gordon and Jeremy Doggett met with a rep from Bluestem Energy Solutions – they want a contract to do a development feasibility study. Walker stated that this is for the municipality buildings only, it isn't for the Village of Lovington. They do run their own lines whether it be wind power or solar power. If after the study is complete and we decide to go with them then they would like to have a contract for 20 to 25 years. Garmon stated that at tonight's meeting we are only deciding if we want to continue with the study. Walker did talk to Jeremy with Good Energy, and he has heard of this company. Walker was told that there are no contracts signed in Illinois. Anklam – we have had good relationship with Good Energy and not sure we should change. Daily – this is way to new and thinks we need to let another community try them out first. Then in a few years if they want to come back to talk to us at that

time, we can contact the other villages to see how it is working. She doesn't think it is a good idea at all. Garmon – doesn't care to look at the contract, he agrees with Daily.

Consensus was to not have the study done.
